Most of us believe that we have lots of time to “get our affairs in order”. Whether it is the gradual creep of dementia, a sudden or severe illness that renders us incapable of managing our affairs, and, yes, even sudden death, this booklet is your guide to being prepared.

The booklet will document your personal & financial information that is helpful in managing your affairs. Let your family or executor know that you have completed it and where it will be located. Then put it in an envelope and tuck it away. If any of the information changes, such as banking, then simply update the booklet and put it away again. You may also wish to give your executor a copy.

This is not a legal document; this is not a substitute for a legal Will or an estate plan. However, your lawyer or financial advisor will be very pleased if you complete this in advance as they will ask you for much of the same information. It will save you time and money.

Social Media Accounts

Unless you have shared your login information to your social media accounts, if no-one tells the site you're dead, your account can stay "active" until the site itself no longer exists.

Different sites have different processes, for example:

Facebook: In your account, you can set up a "Facebook Legacy Contact" who can "memorialize" or delete your account.

Instagram: Verified family members with proper proof upon death can request the page be "memorialized" or deleted.

Google+: There's a "contact if site is inactive" list of people you can set, who will be contacted if you don't use your account in a certain amount of time.

Twitter, Pinterest: An immediate family member must present a copy of their ID and death certificate for the account to be deleted.
